The number of people aged 65 and over is increasing rapidly in the world. In Turkey, the proportion of the elderly population in society will increase by about 8.8 percent, but this rate will increase with years. This speed in aging is a warning to us to do faster and more effective work on what needs to be done in this regard," he said.

Disabled People Gain Skills in Free-To-Be



The Ministry of Family, Labour and Social Services is carrying out studies that prioritize the rights of disabled people and their families and provide support for the independent life skills of disabled people. In this context, it is aimed to spread day-night service facilities free of charge for disabled and disabled families across the country.

With the guidance of master educators in the centers, daily life programs are applied to the disabled entiers with various activities accompanied by professional staff and medical personnel. In order to develop the hand skills of the disabled, work is carried out with the help of master educators assigned by the public education directorates.

Families who care for both the disabled and the disabled at home benefit free of charge from the centers where they are to be employed by providing skills to the disabled. The centers, which are planned to be expanded across the country. Families can participate more actively in social life In the centers, studies are carried out by physical education teachers to enable children with loss of adult age to engage in activities for sports activities. Children's self-care and academic skills are being developed by child development specialist staff.

Children with disabilities in the center, including sleeping rooms, participate in many activities such as music and painting workshop, theatre, folk dances, drama, marbling, sightseeing, picnic, shopping. In the centers where care is provided by certified careers, counseling services are provided to families with disabilities. Families with children with disabilities can spend time and participate more actively in social life thanks to the centers where disabled people receive day care and rehabilitation services. The disabled people who are not trained because they have completed the age of 24 who receive special education guidance, who receive special education guidance, who are going to schools affiliated with the Ministry of National Education, also benefit from the centers free of charge.

Dyslexia Awareness Symposium Discusses the Problems and Expectations of Dyslexia Individuals



Dyslexia Awareness Symposium organized by the General Directorate of Disability and Elderly Services was held in the ATO Assembly Hall on November 6, 2019.

An awareness symposium was organized in the ATO Assembly Hall by the General Directorate Disability and Elderly Services and Dyslexia Learning Difficulties Association to mark **'World Dyslexia Week'** which was celebrated between 1-7 NOVEMBER tarives.

Although the person is at normal or superior intelligence level, dyslexia, which causes problems with reading, writing and language skills, is often observed as a reading disorder. Most of the individuals with this difficulty can also experience attention deficits and hyperactivity. It is especially important to apply early diagnosis and proper training methods related to dyslexia.

On November 25 2015 the first Dyslexia workshop, Dyslexia Awareness Public Spotlight was created in September 2017, May 2016 dyslexia workshop, scenario training, documentary study and short film competition were organized in collaboration with the General Directorate of Disability and Elderly Services and Dyslexia Learning Difficulties Association. November 1-7 was recognized as Dyslexia Awareness Week by the European Dyslexia Association, which is a member of 27 countries.

November 1-7 dyslexia awareness week; Poster brochure work in 81 provinces, public spot work that will return on the public transport screen (Public spot of 2 017 with the logo of our Ministry), on November 6, 2019, in the morning session of families, in the afternoon session for professionals in a total of two sessions for professionals, the symposium events were held in the Assembly Hall of the Ankara Chamber of Commerce.

Minister SELÇUK held talks in Sinop; After the planting event in Sinop as part of the 'Breath for the Future' program held on National Reforestation Day, it opened the Day care center, which was completed in Sinop. SELÇUK, in his speech said that as a government they have traveled very important distances in maintenance services. Maintenance and care support for disabled citizens since 2005 Minister SELÇUK, explaining that they are continuing effectively, stressed that since 2007 they have started to provide home care assistance services.

515.749 Disabled Citizens 4 Billion 514 Million 346 Pounds Payment Was Made

Minister SELÇUK, 515 thousand 749 disabled citizens in 2019 4 billion 514 million 346 pounds were paid pointing out that "We could not ignore the needs of disabled relatives. In order to support our families, we give short term care to our disabled brothers and sisters to our boarding care centers for up to 45 days a year. 609 disabled people benefit from our 67 day care centers, including our center, which we will inaugurate. We also offer boarding care services to more than 27,000 disabled people in 354 care centers."

Minister SELÇUK, the newly opened center sports, art, agriculture, rehabilitation, poultry and mushroom cultivation can be done, he said. SELÇUK then toured the center with the accompanying delegation, received information from the authorities, chatted with the children.

Sample Project: "We Overcome Obstacles with Agriculture"

After the Elderly Welfare Seminar, Avni ÖZKAYA, Deputy General Manager of Disability and Elderly Services, and his companions visited the Greenhouse created in conjunction with Bursa Metropolitan Municipality, Agriculture and Forestry Provincial Directorate within the scope of the "We Overcome Obstacles with Agriculture" Project to provide the rehabilitation of the disabled people who remain in the private care centers located in the garden of Hürriyet High School Agriculture High School. After the visit of the greenhouse, Celal Sönmez Günlü Care Rehabilitation and Family Counseling Center, which was built on an area of 7.898 m², and Hasan Öztimur Nursing Home Aged Care Rehabilitation Center, which is located on an area of 6.234 m², were visited. Turkey Is One of the First Countries to Sign the Convention on the Rights of The Disabled in 2007

Minister SELÇUK reminded that 1500-point disability law was created for the first time in Turkey through the Law on The Rights of the Disabled and sub-regulations, stressing that Turkish iye was among the first countries to sign the Convention on theRights of the Disabled in 2007.

DayTime Life Centers Will Continue to Expand Across the Country

SELÇUK stated that they continue to expand daytime life centers for individuals with disabilities across the country, and said that they have increased the number of daytime centers from 7 in 2018 to 68 in 52 provinces by 2019.

Selçuk emphasized that they attach importance to the employment model that allows disabled people to be placed in work by focusing on their interests, skills and skills, "The number of disabled civil servants appointed by 2002 was around 5,770, while the number of disabled officers assigned during our governments increased by about 10 times and exceeded 55,000. As in previous years, we are trying to cover the cost of ekps exam for our disabled citizens by our Ministry."

SELÇUK informed that day care services are offered in 67 centers in Turkey, "We care very much about day care centers. Because these centers are a source of morale for families, too. Hopefully, we hope that these 67 centers will be a bit of a break for families by spreading them with 81 at the end of theyear."

Minister SELÇUK presented a plaque of thanks to Celal SÖNMEZ, Chairman of the Board of Directors of Sönmez Holding, which undertook the construction of day care rehabilitation and family counseling center. Minister SELÇUK cut the opening ribbon of the center, then examined the building, took care of the children, and participated in their game. Bursa Governor Yakup CANBOLAT, Parliament Human Rights Review Commission Chairman Hakan CAVUSOGLU, Metropolitan Mayor Alinur AKTAŞ and citizens attended the ceremony. Minister SELCUK met with the Women's Economy Platform. Minister SELÇUK was informed about the platform work at the meeting, while the services provided by the Ministry of Family, Labour and Social Services were discussed.

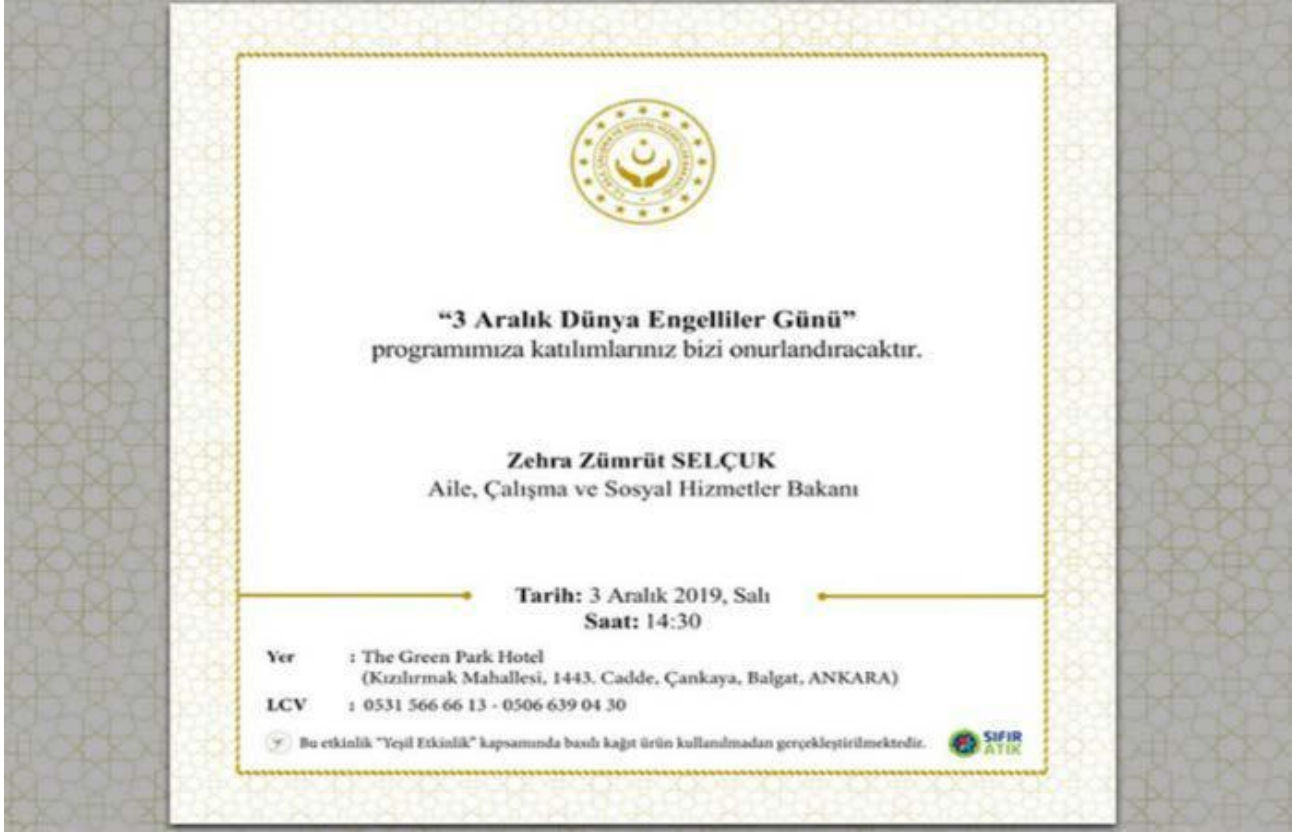

The Organization of Islamic Cooperation (**OIC**) Ministers responsible for **Social Development**, which was attended by President ERDOGAN, was the 1st President of the United **Nations**. Zehra Emerald SELÇUK, Minister of Family, Labour and Social Services, who presided over the **conference**; In 2019, about \$1.2 billion in home care support was provided to more than half a million disabled people, she said.

Minister SELÇUK: 'Strong Is Not Right, Right is Strong'

Zehra Zümürüt SELÇUK, Minister of Family, Labour and Social Services, said of the importance of raising awareness for Muslims that the spread of peace on earth, the establishment of justice, is **"not justified, but strong"** for the **strong**. He said all development efforts are taking people to the center.

Minister SELÇUK in the commendation; "We need to act with the sense of responsibility that our faith has imposed on us, to bring our work in the field of social development to much better levels by strengthening unity and unity among us. It should be noted that if you don't, you're By taking human beings to the center, we can provide both social development and economic development by increasing our qualified manpower.

This assembly, which has gathered here, has opened a window into how we think about different elements of social development. **'Light rises from the east'**, saying that this window, which begins the day with morning prayers, we say 'let the day shine now'. I pray for your precious time for this conference, believing in the heart that time is the time for the Islamic geography to rise again," he said.

Although the Sustainable Development Goals have been cited 11 times for individuals with disabilities and disability, individuals with disabilities are also in the position of achieving many of the targets. In this context, I am proud to express that our government took the first big step in 2005 by strengthening the legal ground with the **Law on The About Disabled**.

In 2007, our **President, Mr. Recep Tayyip ERDOĞAN**, signed the UN Convention on the Rights of the Disabled, and turkey was among the first countries to sign the agreement. As with all our policies, we take a family-oriented approach to our disabled people. We prioritize ensuring that they are taken care of with their families as long as possible. In 2019 alone, we provided about \$1.2 billion in home care support to more than half a million disabled citizens.

Thanks to our encouraging policies, we have reduced employment quotas for individuals with disabilities in the public and private sector. We serve our disabled citizens in our 352 care centers throughout Turkey. We strive to spread accessibility towards our obstacles in our country by saying '**DreamsAre Unhindered**'."

In 2050, one in 5 people in Turkey is predicted to be over 65 years old

Minister SELÇUK "In 2050, we predict that one in five people in Turkey will be over 65 years of age. In this context, in implementing the 2030 agenda, we need to accelerate our preparations to ensure that all age groups can be considered as active elements of social development and to meet the needs of our demographically changing populations."

After the opening speeches, Minister SELÇUK presented a painting to President Recep Tayyip Erdogan.

21 Billion Resources for the Elderly and Disabled in the 2020 Budget from the Ministry of Family, Labour and Social Services!



With Elderly Over 65 in Budget in 2020
11.6 Billion Pounds for Disabled Citizens and Their Relatives who need care, 9.4 billion pounds for support for home care of disabled people.

13.4 billion pounds to the health expenses of their narrow income, 11.6 billion pounds within the scope of pensions connected to disabled citizens and relatives who need care with elderly people over 65 years of age, 9.4 billion pounds for support ing of home care for disabled people, will be in the harcama pens of the budget in 2020.

The budget will exceed 1 trillion pounds in 2020 for the first time in 2020, the 2020

budget, which will come into force on January 1, 2020, will be 1 billion 95 million pounds in size, surpassing the limit of 1 trillion pounds for the first time. The 2020 Budget, which was reduced to the General Assembly of the Assembly, was held on December 20th, and the President's it will come into force on January 1, 2020, with its publication in the Official Gazette submitted for approval.

Family, Labour and Social Services Minister Zehra **Zümrüt SELÇUK**, who participated in the negotiations at the General Assembly of the **Parliament** in the 2020 budgets, stated that disabled citizens have also taken important steps supporting their participation in social life from education to employment. "As you know, we are one of the first countries to sign the Convention on the **Rights of persons with Disabilities** and we continue to communicate with our non-governmental organizations within the framework of social dialogue in accordance with the contract. We will also publish our Unobstructed Vision Document and **the Disability Rights Action Plan**. We care about our **Accessibility Support Project** and we are also working to increase social awareness and awareness in this regard to make it accessible from all over Turkey. We develop evidence-based policies by implementing the National Disability Data Fog, based on reports of disability health institutions. Again, for the first time, we began to draw up the **National Early Intervention Action Plan** for the Disabled. We will soon publish our Unhindered Vision Document and the Disability Rights Action Plan."

We have increased to 69 centers in 52 cities in 2019.

Yenimahalle Visually Impaired Rehabilitation Center Prepares Disabled Individuals From All Over Turkey to Life

Yenimahalle Visually Impaired Rehabilitation
Its center prepares disabled individuals from all over Turkey to life.

In order to facilitate the harmony of individuals to life and to help them solve the psychological and social problems caused by disability, trainees are brought to social life at Yenimahalle Visually Impaired Rehabilitation Center.

Ministry of Family Labor and Social Services, all expenses covered by the organization provides 2 semesters of education per year. The training, which runs from September and February, serves 30 visually impaired individuals who have exceeded the compulsory education age. A total of 60 trainees year have vocational, social, and educational improvement programs. Trainees are trained in independent life techniques in many areas that facilitate their daily lives such as ironing, laundry folding, kitchen skills, relief writing, power plant training. This rehabilitation and training are also given to facilitate their adaptation to life.



While the trainings are processed in 2 modules as Basic Education and Vocational Training, trainees are given independent action, personal administration, relief writing, abacus, snetwork courses, power plant, computer and business workshops in vocational training within the scope of basic education.

The center, which provides 2 semesters of education in 7 areas, welcomes 60 students a year. Students over the age of 15 from 81 provinces can also remain as boarders. Expenses were paid by the General Directorate of Disability and Elderly Services of the Ministry of Family, Labour and Social Services and 3,073.376.63 TL in 2019 to **Yenimahalle Visually Impaired Rehabilitation Center**, which provides boarding and day-to-day services throughout the country.



Success Stories of Visually Impaired Rehabilitation Center Trainees

Okan ALTINKAYIK: With his trainings from the Visually Impaired Rehabilitation Center, he completed his primary-Secondary-High School education from open education. Samsun graduated from 19 May University, a division of history. While studying at the university, he was appointed as a servant to a school affiliated with the Ministry of National Education. He is waiting to move on to the teaching staff.

Ismail YİĞİTER: Without knowing how to speak Turkish, he came to the Rehabilitation Center for the Visually Impaired. He learned to speak, read, and write Turkish. 1st and 2nd. He completed his level training through the center and took care of his own business independently.

Olca AŞCI: Besides his technological talent, he developed himself very well with the trainings he has received here. He started a job at a GSM operator.

Lawyer Gizem AKSAÇ: While studying at law school, the accident lost the ability of the presenter to see. Thanks to the basic education he has received from the Visually Impaired Rehabilitation Center, he continues his school and business life without problems. He works as a lawyer in Yenimahalle Municipality.

Vedat LAUGHED: He was not literate when he came from the Visually Impaired Rehabilitation Center. He completed 1st and 2nd his level training and took care of his own business independently.



Visually Impaired Teen Prepares Multi Extra Program, Uses 600 Thousand People around the World

Ahmet SETTAR, a 22-year-old visually impaired who came to Turkey years ago and settled in Turkey, has prepared a special software program used by 600,000 visually impaired individuals around the world based on the difficulties he experienced. **Settar,** which facilitates the lives of thousands of disabled citizens with its education in Turkey, amazes those who see the tenacity. Based on the difficulties he faced in his life, he was sepulsive and developed a video software program that would facilitate the good toll of the

The dissemination of accessibility will be encouraged. Day life centers for people with disabilities have been increased to 68 centers as of 2019. It's a nationwide expansion in 2020. **A National Early Intervention Action Plan** for the Disabled Will be prepared. The Certificate of Vision of the Elderly will be supported by active aging and the strengthening of the elderly' rights will be provided. **The Elderly Support Program (YADES)** will be expanded in provincial municipalities in 2020.

SPECIAL CHAPTER

EMPLOYMENT OF DISABLED INDIVIDUALS IN OUR COUNTRY



The policies applied in employment in the world in general are divided into active and passive employment policies. Active employment policies are mainly market-oriented policies aimed at improving the skills, professional qualifications and entrepreneurship of both unemployed and working individuals, while passive employment policies are policies that return to providing non-market and minimum income security, such as unemployment insurance, social welfare and social care. A similar approach has been adopted in the employment of individuals with disabilities and it is seen that disabled people are more likely to participate in the working life in countries that prioritize active employment policies. In countries where active employment policies are low, it seems that the reasons for the misconceptions that exist in society for individuals with disabilities, the prejudices of employers, the low professional qualifications and skills of disabled people, are effective in this way.



The most widely used method in disabled employment all over the past to the present has been the "quota method" that expresses the obligation to employ people with disabilities in a certain number or proportion. Is it a positive discrimination application that makes it easier for people with disabilities to enter the business life in the direction of quotas? In our country, the quota/quota-penalty method in disabled employment with its history dating back to the 1970s remains in this field. However, starting from the beginning of 2000 years in the employment of disabled, some other employment methods have started to take their place in practice along with the quota method. In the process, on the one hand, new measures will be strengthened in the public and private sector

as a qualitative and quantitative employment, while on the other hand, establishing its own business, subsidised employment, protected employment and Some other methods, such as assisted employment, have sometimes begun to show their presence in the field through regulatory arrangements and sometimes through projects.

Employment Policies and Job Market Programs for Individuals with Disabilities in Turkey

When we look at the legal regulations reflecting the policy of the disabled in our country, we see that the rights of the most comers are protected in the content of the laws on education, health, employment, social security and full participation insociety. Our country has secured the basic rights of disabled people with both the international conventions it has signed and the internal legislation, especially the Constitution.

The issue of disability is now considered a human right. The subject of rights and rights to the people with disabilities is now considered as autonomous individuals who have authority and decision on their own lives, not as individuals in need of protection and assistance, decided by others about themselves.

It has emphasized and importance that all people will benefit from these rights in all international rights comprehensive documents agreed on, starting with the Universal Declaration of Human Rights adopted in 1948 by the United Nations (UN). In practice, it is accepted at a global level wherdisabled people are deprived of basic rights and freedoms that other individuals have. With this acceptance, the UN adopted the Convention on the Rights of the Disabled in 2006. Turkey is among the first one to sign this Agreement.



The Convention on the Rights of Persons with Disabilities describes the obligations of states to ensure the protection, promotion, and development of human rights of individuals with disabilities. The agreement does not establish new rights, but it has a complementary qualification for the disabled in existing human rights agreements. Article 27 of the Contract, entitled "Employment and Work"; that people with disabilities have the right to work under equal conditions with other individuals, that they can earn their lives in a job they freely choose in an open, integrative and accessible work market and working environment

and States Parties are obliged to take measures to ensure this.

Employment policies for people with disabilities in Turkey, particularly the Constitution, are regulations. In addition to the principle of equality imposed by the Constitution, the positive discrimination principles stipulated by the regulations are the basis of employment policies for the disabled.



Place in the Constitution the Law on Disabled People, which came into force in July 2005 and was revised in 2014 in line with the, it has been an important anti-discrimination and disability rights document.

The Law on The People of Persons prohibits all forms of discrimination based on disability, including direct and indirect discrimination, demands that reasonable arrangements for people with disabilities be taken to ensure equality and eliminate menstruating, and stress that special measures to ensure that disabled people benefit fully and equally from rights and freedoms cannot be considered discriminatory. The law also prohibits all forms of disability-based discrimination at all stages of employment, mandates reasonable regulation of the needs of disabled people in workplaces, and regulates protected workplaces for the mentally and mentally disabled who have difficult employment in the open labour market.

In our country, employment policies for people with disabilities are largely based on quota and quota/penalty system from its history dating back to the 1970s. Various obligations have been imposed on public and private sector employers in order to employ people with disabilities. However, in recent years, some other employment methods have begun to take part in practice.

As the table shows, according to the results of the 2011 Population and Housing Survey, the participation rate of disabled people in the workforce in our country was 22.1%, while the non-employment population was 77.9%.

Quota/Quota-Penalty Method

Employment policies for disabled people are based on the quota method in our country. In this context, the quota/quota-penalty method is regulated by the Civil Servants Law No. 657 and the Labor Law No. 4857 and the regulations issued under these laws. Various obligations have been imposed on public and private sector employers in the ability to employ people with disabilities. Criminal sanctions have been envisaged for employers who do not fulfill their responsibility for the employment of disabled people as workers.

Disabled Officer Employment

In the Civil Servants Act No. 657 adopted on July 14, 1965, the recruitment of disabled people is regulated by Article 53.

Disabled Public Personnel Selection Exam

On 13.02.2011, the Public Servants Act was amended and examinations for the recruitment of disabled civil servants (Disabled Public Personnel Selection Exam-EKPSS) were brought to public institutions. With the regulation, the examinations for the disabled, for the first time to be appointed as civil servants, as the same time and center, as long as there is a disability quota gap, the exam question is prepared and accessibility as of the obstacle groups and educational situations are made centrally or made. With EKPSS, general talent and general culture tests are applied to candidates in accordance with obstacle groups and learning levels.



General talent test; (orthopedic, duration (chronic), spiritual and emotional, common developmental disorder), hearing disability test: mental disability test, visually impaired test is applied. In addition, material and reader-marker support are provided to suit the obstacle situation.

When we look at the statistics of the disabled officer, the number of 5,777 in 2002 increased from 55,196 in November 2019 to 55,196, and 35,644 placements in this number are understood to be with four central examinations conducted since 2012 (DPB, 2019).

Disabled Worker Employment

Employment of disabled workers in our country was organized under Article 30 of the Labor Law No 4857. Accordingly, "Employers are three percent disabled in private sector workplaces where they employ fifty or more workers; in public workplaces, four percent of disabled individuals are obliged to play in jobs in accordance with their professional, physical and mental state.

In cases of article 101, penalties to be collected in accordance with Article 101 in cases of violation of Article 30 with the regulation made in the Labor Code in 2003 and 2011; support technologies that will enable disabled people to start their own business, to get the disabled to work, to ensure compliance with the disabled, to work and to work, and to be used in such projects. In this context; employers can also benefit from this fund in order to provide new technologies and necessary tool-facts to individuals with disabilities in the workplace.



The use of the resource collected in the fund for projects aimed at the employment of disabled people has been one of the important developments in the field of disability employment.

In accordance with İŞKUR data, a total of 123,907 disabled workers are employed in the public sector as of the end of November 2019, including 16,151 in the public sector and 107,756 in the private sector (İŞKUR, 2019).

Protected Employment

The Protected Employment Model, an alternative employment method for individuals with mental and mental disabilities, which is difficult to bring into the open labor market, is carried out in workplaces that are technically and financially supported by the state and the working environment is specially organized. If the employer of the workplace where at least eight mentally or mentally disabled individuals work meets the other conditions specified in the Regulation on Protected Workplaces, the employer can apply to the Provincial Directorate of Family, Labour and Social Services in the provinces to obtain a "protected workplace status certificate".

With the provisions of support; Reduced income and corporate tax for protected businesses, exemption from environmental cleaning tax of protected workplaces, some of the salaries of disabled persons working in protected workplaces and their employers' unemployment insurance premiums are covered from the Treasury.

Within the scope of financial support, employers are paid every month and for each disabled person, which is TL 805.62 for the first six months of 2020. As of January 2020, 90 disabled individuals are employed in 10 protected workplaces in our country.



Protected Workplace Grant Projects

Protected workplace grant projects are jointly coordinated projects by the General Directorate of The Turkish Employment Agency and the General Directorate of Disability and Elderly Services. Only businesses that receive protected workplace grant projects can apply.

In accordance with the legislation of İŞKUR and budgeted expenditures as estimates in the project proposal are supported and the projects decided to allocate resources are given the following supports:

- a) Foundation capital support: 60% of the foundation capital of the protected workplace to be established within one year from the date of establishment (up to 150,000 TL),**
- b) Disability wage support: Disabled workers who will work in protected workplace established from the beginning of the project pay for the first year on the minimum wage,**
- c) Operating expenses: 60% of the invoice cost of operating expenses (water, electricity, heating, communication, recognition) for one year from the date of signing of the contract,**

The protected workplace to be established within the scope of the project is subjected to İŞKUR and MoFLSS tracking and subject to the subject of the investigation team by the Commission for 3 years, and the sales or transfer of machinery and equipment received within the scope of the project cannot be made within a period of 3 years. If the protected establishment is closed for any reason within 3 years, excluding force majeure reasons, liquidation or the number of working disabled people falling below the specified number, the foundation's capital, which is initially given as a grant, is withdrawn with its legal interest.

Within the scope of the protected workplace project, a total of 31 project applications were submitted in 2013 years, including 13 projects in 2014, and 12 of these projects were accepted by the Commission. 2 of these projects adopted have been implemented and projects that cannot be implemented have been cancelled by Komisyon. In addition, 4 projects in 2017 and 3 projects in 2018 have been accepted by the Commission and these projects are still operational. 1,979.909.40 TL resources have been allocated to these projects (İŞKUR, 2019).

Subsidized Employment

In addition to quota/quota-penalty method and protected employment method, the employment method, which is subsidized to some extent, is applied in the employment of disabled persons in our country.

In this context, an arrangement was made in Article 30 of the Employment Law No. 4857 and incentive stipulations were implemented for employers. According to this arrangement, All employer's shares of insurance premiums, which are calculated on the prime principal earnings sub-s of disabled insurers employed by private sector employers and employed in protected workplaces, are covered by the Treasury.

This application is also used by employers who work with disabilities and employ more quota disabilities, even though they are not obliged. In addition, as detailed as described in the up- to the up, the wage subsidy for employers has been put inplace for individuals with disabilities employed in protected workplaces.



Various incentives have been introduced to individuals with disabilities within the scope of subsidized employment. In this context, individuals with disabilities tax rates in accordance with and varying rates discount application.

As part of the disability discount; Income Tax No. 193 According to Article 31 of the Act; working those who have lost at least 80% of their power people with degrees Impaired, who have lost a minimum of 60% second-degree disabled, lost at least 40% those found are considered to be third-degree disabled.

Accordingly, the disability reduction, the wages and/or gains of those who have lost their workforce, according to the degrees they will enter, the discount is applied. From the practice of disability deductions according to the Income Tax Act; Disabled paid, dependent disabled people with paid, disabled free-kicker, dependent slek person with disabilities, self-employed people with disabilities and individuals with disabilities who are taxed in simple ways can benefit.

Setting Up Your Own Business

The work on behalf of the person who has become increasingly important in the employment of the disabled in recent years and mentioned as a method of setting up his own business in the summer of the field has started to come up more in recent years. It is hoped that the benefits of this fund in sustainable areas where individuals with disabilities are trained and benefited from this fund in sustainable areas can bring ab-for-future qualification to employment.

In order to benefit from this support, it is necessary to have received entrepreneurship training organized by KOSGEB and İŞKUR and to apply with a project. In this context;

- Support for enterprise operations: A maximum of 3,000 TL for including a document for expenses such as official transactions, approvals, permits, licenses, and insurance for the establishment,
- Operating expenses support: A maximum of 11,000 TL per year, not exceeding 60% of operating expenses (water, electricity, communication, heating, promotion, and rent) for 12 months after the contract signing date.
- Establishment support: A total of TL 50,000 is provided in three titles, including taxes for costs such as machinery, equipment, software, hardware, intermediate, consumables, office supplies, and office supplies related to the basic area of activity related to the business's basic area of activity, including 12 months from the date of signing of the Contract.

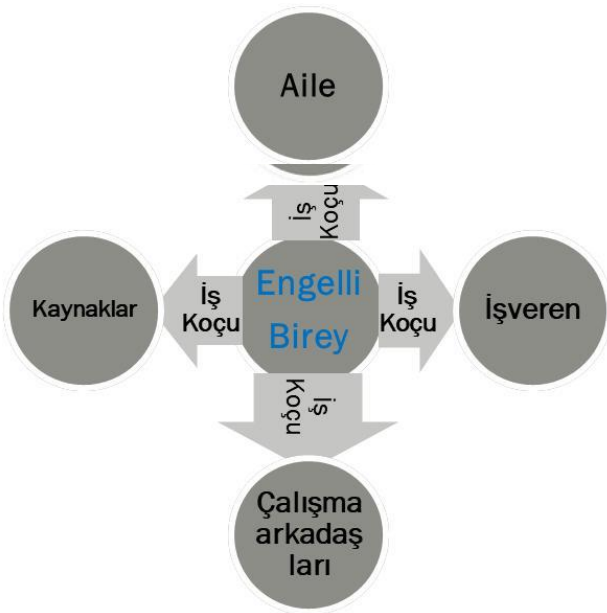
In this context, 58 million 488 thousand resources were transferred for 1417 projects between 2015 and 2019 for projects to start their own businesses with disabilities (İŞKUR;2019)

Assisted Employment

In various countries around the world, the employment of people with disabilities has traditionally begun to show the existence of "assisted employment" while using methods such as quota method, quota-penalty method, protected employment, reserved employment, subsidized employment, and has become an effective method that is becoming increasingly common in the world for the recruitment of disabled individuals into the open labor market. Individuals with mental disabilities, individuals with learning disabilities and individuals with mental health problems have ensured successful results in various countries in ensuring the employability.

Assisted employment; it is based on the principles of "human rights" and "full participation" for individuals with disabilities. It is a "social model" that treats an individual with disabilities as a citizen with equal rights to other individuals of society, and is a rights-based employment method.

Assisted employment is defined as a way that supports disabled individuals in the open labor market in terms of finding an income-generating job and being permanent in that business. Here, the key word is "support", which includes supporting the disabled individual before work, during and after work, as well as supporting the employer. This support is often provided by a business coach, employment specialist or business and professional consultant with its widespread use in our country. The perspective of assisted employment is not to focus on what the individual cannot do, but to focus on his abilities and what he can do.



Supported employment in our country has not yet taken its place in the legislation. In parallel with the course of development that this method has followed in all the countries in which it demonstrates its existence, it has begun to show its presence in recent years with national and international projects by various public institutions and non-governmental organizations.

Join the Job Initiate Project

(2014-2018)

The Participat in Life Project, which aims to contribute to the implementation of the assisted employment model for bringing the m esleki skills and work practice to ensure the need of the business world at the local level, which meets the needs of the business world at the local level, and to ensure its participation in the workforce, hasbeen implemented in June 2014 in cooperation with the private sector. The first phase of the project, which took place in two stages, was completed in July 2016 and the second phase in July 2018.



In the first period of the Participation In-Force Project, a modelling study was carried out in Ankara, Istanbul, Sakarya, Samsun and Gaziantep for the development of assisted employment model in Turkey. It was aimed to train job coaches to guide disabled people in areas that comply with their abilities and skills. In this context, 300 disabled individuals were targeted in the open job market in the provinces mentioned with the support of 60 business coaches raised, and 447 eng fifty individuals were placed on the job.

Within the scope of preparatory work in the first phase of the project; The selection of job coaches, the preparation of the training package to be given to the job coaches, the development of a draft of professional qualifications and a wide range of studies on the field and the necessary matery have been examined. At the end of this stage, the selection of job coach candidates among individuals with training package was prepared, job and professional consultancy certificate satisbined and the selected candidates were given job coaching training without less than 60 hours. 40 percent of trainings are intended to improve the level of knowledge of job coach candidates, while 60 percent are intended to provide the skills they need on the field. In these trainings; Disability and rationingm, employment-related legislation, behavior arrangements in individuals, skills teaching, business analysis, communication/cooperation, documentation/evaluation and problem solving are focused on.

Completing their training, the business coaches started their duties in the aforementioned provinces and carried out their work for the employment of disabled individuals in the open job market with the goal of matching correctly between the business world and individuals with disabilities. In this context, of the 447 placements in the first phase of the project, 78.5% were men and 21.5% were women. The highest placement was in orthopedic handicapped with 26.6% and disabled people with ongoing disease with 26.3%. The placement rate in individuals with intellectual disabilities was 9.4% (General Directorate of Disability and Elderly Services, 2019).

At the end of the first phase of the project, 74 of the 447 disabled individuals with sustainable employment were interviewed face-to-face, and it was determined that all disabled employees who participated in these interviews had a positive impact on the project's own lives and social cohesion. In addition, all relatives of disabled people in interviews with the families of disabled individuals made positive statements about the project. A similar period was carried out with 82 employers or employer representatives, in general, employers found disabled individuals in areas such as their determination to work, fulfilled the tasks given, high sense of responsibility, and some employers found disabled individuals inadequate in terms of their socialization skills and professional knowledge level (General Directorate of Disability and Elderly Services, 2019).



In order to test the data volume of the model developed in the first phase of the project covering 2016-2018, it is aimed to measure the effect by placing them under different conditions in various provinces and to identify the factors that affect the effective use of the model in country conditions.

The second phase of the project, which targeted 15 business coaches and 300 placements in Ankara, Istanbul and Izmir provinces, resulted in 450 placements, and 28 percent of the disabled individuals placed were women and 72 percent were men. During this period, the highest placements were in the disabled with orthopedic (18.2%) and duration disease (19,8%) while the placement of mental disabilities increased by 9.4% in the first period to 14% (General Directorate of Disability and Elderly Services, 2019).

According to the results obtained by interviewing 272 individuals from different obstacle groups and different business areas from 450 disabled individuals, the satisfaction of disabled individuals from the work coaches was extremely high. Individuals with disabilities have both broken their prejudices against the business world and could socialize by working with business coaches who support and guide their ke ndi in the workplace. Within the scope of the interviews, 272 workplace managers generally expressed their thoughts on the participation of disabled individuals in their working lives, while 14.7% said that disabled employees could not carry out different tasks when necessary (General Directorate of Disability and Elderly Services, 2019).

Turkey Supported Employment Practices Sharing Meeting 25 April 2019

On April 25, 2019, the Meeting was held at SGK Kavaklıdere Training Facility, attended by the Employment and Social Security Department of the General Directorate of Disability and Elderly Services, public institutions, non-governmental organizations, social sectors, and private sector representatives. It is designed to reveal the overall outlook of the supported employment practices that exist in our country and to evaluate the steps for the future with all parties.



The meeting emphasized that assisted employment is a system that enables people with disabilities to acquire skills to meet the needs of the job market, to have jobs based on their own characteristics and preferences, and that assisted employment programs cover ongoing support services provided for a disabled person to learn and perform their jobs.

In meeting, shared that It was stated that the ministry of family, labour and social services participated in the recruitment project in our country with the project implemented by public institutions, various non-governmental organizations and the private sector, successfully carried out, positive results were obtained, and in this context, in 2018, a comprehensive supported employment project was started by İŞ-KUR.

Turkey Supported Employment Practices Sharing Meeting chaired by The General Manager of Disability and Elderly Services Md. Orhan KOÇ, disabled services in our country is applied with a right-to-be with a right-to-be, he said. The general manager expressed the importance of day-to-day services and gave information about the disability employment policies and assisted employment practices implemented in our country.

Md. Orhan KOÇ emphasized that it is important to develop and disseminate assisted employment services by sharing supported employment studies and knowledge, experiences and experiences obtained in the field, carried out by public institutions, civil society, and private sector

Regarding assisted employment projects, "Join the Work Inlife Project" project carried out by our Ministry Assoc. In addition to the presentations of Md. Necdet KARASU, presentations of ÇASGEM, non-governmental organizations and private sector representatives were made, and opinions were exchanged.

Other Supported Employment Projects and Activities Carried Out in Our Country



In 2018, the "Disability Job Coaching" project was started by the General Directorate of AÇSHB Turkish Employment Agency. The project is still being implemented and is being carried out in 8 provinces.

Another project implemented by the public within the scope of supported employment is the Education and Quality Assessment Tools Design Project for the Qualifications of Business Coaches carried out by the Ministry of EH Education Research Center (ÇASGEM) in 2015-2018. Pilot trainings have been given within the scope of the project, which aims to produce learning outputs based on curriculum and educational materials linked to ECVET (Credit Transfer System in Vocational Education and Training).

With these projects, similar projects have been implemented by various non-governmental organizations. One of these projects is the Independent I am working for since 2012 by the Down Syndrome Association. Within the scope of the project, 86 individuals with down syndrome were provided with qualified sustainable employment in the open labor market (DSD, 2019). A similar project carried out by the International Down Federation (UDF) aimed to ensure that individuals with down syndrome are employed in corporate workplaces in cooperation with udf and the Association of Phoenix. In 2018, the employment of 3 individuals with down syndrome was provided and the project was continued with the goal of 17 provinces and 106 young people for 2019 (UDF, 2019). Another development in the field of assisted employment in our country was the establishment of the Assisted Employment Association in Istanbul in 2016. Erasmus Plus KA2 between 2014 and 2016: Cooperation Strategic Partnership Project for Innovation and Good Practice Change (Job Coaching Training: Place, Train, maintain for people with Intellectual Disabilities) was carried out. In the project, 49 participants were trained in employment and job coaching by the Irish KARE organization. (ISDER, 2019)
